CALLANDER COMMUNITY COUNCIL – REPORT FOR APRIL 2023 MEETING.

Roads, Pavements, Cycleways and Car parks.

4] Callander, A84, Refurbishment of pavements bounding A84/ Main St etc.

Authority – Bear Scotland.

Background – Over the last few years Bear Scotland refurbished the A84 carriageway and the street lighting.

Present Position: Email to Bear 23/5/22 seeking proposals for the pavements bounding the A84/Main St etc.

Email 24/5 22 from Bear Scotland confirming that their planned maintenance team has a footway resurfacing scheme programmed for October 22 – note out with tourist season. 13/9/22 Email to local wheelchair user asking him to provide me with marked map indicating locations where existing dropped Kerbs are not fit for purpose or don't exist. 13/9/2 Latter person indicated he would prepare same for me for passing to Bear. 18/9/22 List of Dropped Kerbs needing attention or provided passed to Bear Scotland to incorporate into proposed programme for refurbishment of pavements. Email 23/9/22 from Bear will include the Dropped Kerbs suggested above. 2/12/22 Email to Bear seeking details of progress on the issue. Email 22/12/22 from Bear delayed due to budget, programmed to be designed this financial Year with construction programmed for next financial year. Email 1/2/23 from Cllr Earl re meeting with Bear re progress of above Meet arranged with Bear for 10 am 3/2/23 to discuss same. Outcome of meeting with Bear 3 Feb 2023 attended by Cllr Earl.

Potentially three sets of works.

- 1] Finish resurfacing A 84 through Callander.
- 2] Upgrade Box Junction
- 3] Footway improvement works.

Bear presently awaiting finalization of budget for 2023-24.

Meeting to be held on 3 Mar 23 with Bear re progress - attendees Cllr Earl. David Shearer and Bear rep. Meeting held with Bear 3 Mar 23 where it was agreed a meeting on site once Transport Scotland have confirmed Bears Budget and they know what funds they have available. Bear will come back to Martin and myself and let us know the outcome and arrange a meeting to progress.

Background – Stirling Council presently refurbishing lighting in Callander.
