Other Incidents / Activity of note

We are aware of a high number of online posts regarding houses being marked with paint / chalk / cable ties and possible links with dog thefts.

This is similar to historical online posts regarding house's being marked and identified for house breakers.

We are unaware of any recent dog thefts in the Forth Valley area. We have not seen any evidence to show that any crimes in our area are linked to houses or streets being marked in any way.

Unfortunately we live in a world where anything with value, including pets can be targeted by criminals and we should all be taking sensible precautions.

House holders should consider inside timed lights, outside general lighting and security lighting round their property especially at this time of year. Some home owners get alarms fitted and CCTV installed which can further deter criminals.

Doors should always be locked, even when you are in the house. Pets should be monitored when not within your home.

Keys should not be left within a straight line view of a door with a letter box as persons have been known to use garden canes, extendable poles and fishing rods to hook house and car keys.

You should not engage with cold callers at your door. You can always contact charities direct via phone or online if you wish to donate money. If requiring work to your house get more than one quote from recommended or local companies.

Suspicious people and vehicles should be reported to Police at the time of seeing them and registration numbers noted where possible.

The fear of crime effects more people than crime itself. We recognise that social media can be a great tool when it comes to sharing information but only when that information is accurate and based on fact.

By taking every day sensible precautions to reduce the risk of being a victim of crime you are giving yourself peace of mind that you have done what you can.
