MAIN FOCUS

This has been on the ongoing visitor management problem, as it affects residents and businesses as well as visitors, through fact-finding and ongoing discussions with the relevant bodies: Stirling Council, LLNTP, Transport Scotland and others to find a workable integrated course of action.
