**Ward Plan Priorities**

**Antisocial Behaviour**

**You are concerned about antisocial behaviour including drunken behaviour.**

On the 15/05/21 following a disturbance at the Waverley Hotel, one male was issued with a Recorded Police Warning in relation to Threatening and abusive behaviour.

On 05/06/21 property was damaged within a B&B premises in Callander with one male being charged with vandalism and is the subject of a report to the Procurator Fiscal.

When available, Police along with National Park Rangers have been carrying out extra Patrols in the area. Considerable time has been spent engaging with visitors in with a view to reducing antisocial behaviour, littering and dangerous parking.

**Road Safety**

**You are concerned about speeding, dangerous driving and indiscriminate parking.**

Whilst on mobile patrol on 11/05/21 Police stopped a vehicle in Callander and the driver was found to have no MOT or insurance. The driver was charged and will be the subject of a report to the fiscal with the vehicle being seized by Police.

Whilst on mobile patrol on 30/05/21 Police stopped a vehicle, Main Street, Callander, and found the driver to be under the influence of alcohol and over twice the legal limit. The driver was arrested and charged and is the subject of a report to the Procurator Fiscal.

Police Constable Deans and I have been carrying out joint visits to licenced premises in the Callander area along with the Stirling Council Licensing Standards Officer and Environmental Health Officer. We have been doing this with a view to assisting and advising owners and managers in relation to the new and ever changing rules and legislation that has been put in place to reduce the risks covid poses.

On the 31/05/21 following community intelligence a Search Warrant, granted under the Misuse of Drugs Act was executed in Callander. One male was found in possession of a small amount of cannabis and was issued with a Recorded Police Warning.
