	In the early hours of 29/08/21 an incident occurred at the Dreadnought Hotel whereby a male was assaulted. Enquiries are currently ongoing.			
	On 03/09/21 police were contacted by a member of the public with concerns for a male within a vehicle on Invertrossachs Road. Police attended and found the male to be safe and well however he was issued with a recorded police warning for being in possession of a small amount of controlled drugs.

### **Road Safety**

You are concerned about speeding, dangerous driving and indiscriminate parking.

On 03/09/21 PC's King and Deans, along with traffic officers, carried out close pass patrols on Main Street, Callander. 3 drivers were stopped regarding their speed, 1 driver stopped regarding driving whilst using a mobile phone and 2 cyclists given safety advice.

On 04/09/21 a traffic collision occurred on the A81 involving 2 motorcyclists and a vehicle. The road was closed for several hours whilst traffic officers carried out an investigation.

On 05/09/21 a vehicle came off the road on the A84 near to Callander. As a result of this, the driver has been reported to the Procurator Fiscal in relation to a road traffic offence.

Over the past month or so, police have received concerns regarding parking of vehicles and motorhomes on Tulipan Crescent, Callander. At present there are no parking restrictions on that stretch of road. PC's King and Deans met with Stirling Council who are going to look at options with double yellow lines.

#### Theft

You are concerned about homes being broken into and travelling criminals.

There have been no reported thefts in the area.
